BSLA President, Dennis Loots, called the meeting to order at 9:37am

- Dennis has not been able to get DNR to respond. He will continue to pursue.

7. Info on newer Local Campgrounds

- *Proposed Bocan Campground* There are two lawsuits on this working through the system
- Existing Peterson Road Campground no new news, appears to have limited usage
- Existing Campground on 70 planned expansion no new news
- Existing Norman's landing open, limited usage so far

9. DNR CBCW (Clean Boats-Clean Water) Grants

- Chip looked into DNR grant process via Jill Sutherland at DNR. Cycle is one year to apply. May 1st, Sept 15th application dates.
- BSL could apply for Surface Water Grant even though lake doesn't meet NR1.91 (public access min 25 parking units space)
- CBCW grants only fund program to staff boat landing invasive species inspection and education
- Grants only applicable if association by-laws follow DNR policy of membership within 1 mile from lake and demonstrated lake association paid membership of 25+. There is a loophole which can mitigate the 1 mile rule since our association bylaws state within 1000 feet of lake
- After discussion we are not going pursue a DNR CWCB Grant at this time

10. Excessive Canadian Geese on Big Sand Lake Project

- Two DNR people came to Jane's lot to discuss the project. The DNR will come at end of June and Band geese using 5 trucks and kayaks. They will herd all the geese they can into Jane's lot, then will band the Geese. Just banding them will disturb them enough to get some geese to leave the lake. The DNR is interested in the data from the bands to track migration. The DNR will not remove any geese at this time.
- Jane also volunteered to talk again to the DNR person responsible for the DNR boat landing

11. BSL Lake History Project

• No news, didn't get started on this yet

12. Automated Lake water monitoring system. Paul

- Monitors: Air temp, water temp, solar light, turbidity, chlorophyll, algae. Keeps historical tracking data.
- Two options:
 - (1) Buy up front/own it. \$8,500 One Time Cost.
 - (2) Subscription price 8 months/year monitoring \$2000 per year + One time \$1500 cost for unit. So \$3500 total 1st year cost.
 - Units last 7-8 years.
 - General discussion on value of device vs cost, what to do with results, liability issues with publishing the data and having device in lake, etc, etc
 - Chip made a motion for Paul to present at the July annual meeting. Karen 2nded motion.
 - Discussion: The purpose for presenting at the meeting is to see if there is enough interest from members to proceed further investigation from the larger association. The approach would be for 1-2 year trial. Possibly solicit champions from the organization to donate cash to fund initial unit. Dennis will reach out to DonB on his view since he was not at the meeting
 - Vote taken to bring this topic to July meeting: 4 yes, Karen was opposed.
